Escambia County-Prepares for Closures

Tropical Storm Arlene is passing through Escambia County.

- **Evacuations**
 - On the present track, citizens who evacuated should be able to return to their homes around 6:00pm this evening.

- **Shelters**
 - The following public shelters will close around 6:00pm:
 - **Civic Center**, 201 East Gregory Street
 - **Blue Angel Elementary**, 1551 Dog Track Road, Pensacola
 - **West Florida High**, 2400 Longleaf Drive, Pensacola
 - **Carver Middle School**, 440 East Hecker Road, Century
 - A Special Needs shelter will **also close** at **Pensacola Junior College, Lou Ross Center**, 1000 College Blvd, Pensacola.

- **Emergency Operations Center**
 - The EOC is planning to deactivate shortly after 7:00pm this evening.
 - Damage assessment teams will go out on Sunday.

- **Escambia County Area Transit**
 - All bus service will resume normal routes on Sunday.

- **School District**
 - Damage assessment teams will check the schools on Sunday.
 - Not aware of any significant damage to school facilities.
 - Normal operations expected to resume Monday, including summer school.
 - Parents should monitor local media outlets for information on Sunday evening.

- **Pensacola Junior College**
 - All classes to resume on Monday.

- **Solid Waste Management**
 - The Perdido Landfill will reopen with regular hours on Monday, June 13, 2005.
 - The Oak Grove Citizen Convenience Center will reopen on Wednesday, June 15, 2005.

- **Escambia County Animal Shelter**
 - Will reopen Monday, June 13, 2005.
 - Only emergency calls will be handled by Animal Control Officers over the weekend. Please call 595-3080 for emergencies.

- **Transportation**
 - Santa Rosa County Sheriff's Office closed the Navarre Bridge
 - Tolls are suspended on the Garcon Point and Mid-Bay bridges. Tolls are currently scheduled to be reinstated at 5:00 p.m. Saturday, June 11, 2005.

- **Emerald Coast Utilities Authority**
 - The water main break on Via Deluna east of Sugar Bowl has been repaired.

- **Gulf Power**
 - As of 2:00pm, 7,149 customers were reported without power.
 - Power crews will work as long as winds are under 30-35 mph.
 - Customers may report outages by calling 1-800-GU-POWER (487-6937).

- **Escambia River Electric Cooperative, Inc.**
 - Scattered outages are being reported.
 - Crews are working to quickly restore power.

- **Pensacola Regional Airport**
 - Flights are expected to resume this afternoon.
 - Please check with your air carrier for specific flight arrangements.
